## **THE PUNJAB APPROPRIATION ACT, 2014** (Punjab Act No. 4 of 2014)

### AN

### ACT

to authorize the payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Punjab, for the services and purposes during the financial year, 2013-2014.

BE it enacted by the Legislature of the State of Punjab in the Sixtyfifth Year of the Republic of India as follows:-

> 1. This Act may be called the Punjab Appropriation Act, 2014. Short title

2. From and out of the Consolidated Fund of the State of Punjab, Issue of Rs. there may be paid and applied sums, not exceeding those, specified in column 5 of the Schedule, appended to this Act, amounting, in the aggregate, to a sum of Rs. 51,01,67,88,000/- (Rs. Five thousand one hundred one crores sixty seven lacs and eighty eight thousand only) towards defraying several charges, of Punjab for the which will come in the course of payment to be made during the financial year, 2013-2014, in respect of the services and purposes, specified in column 2 of the said Schedule.

51,01,67,88,000/out of the Consolidated Fund of the State financial year, 2013-2014.

3. The sums, authorized to be paid and applied from and out of the Appropriation. Consolidated Fund of the State of Punjab by this Act, shall be appropriated for the services and purposes, specified in the said Schedule, in relation to the financial year 2013-2014.

4. Notwithstanding anything contained in any other Act for the time Overriding effect of the Act being in force, the provisions of this Act shall prevail.
