No.5-Leg./2014.- The following Act of the Legislature of the State of Punjab received the assent of the Governor of Punjab on the 14th Day of March, 2014, is hereby published for general information:-

THE PUNJAB APPROPRIATION (VOTE-ON-ACCOUNT)

ACT, 2014

(Punjab Act No. 5 of 2014)

AN

ACT

to authorize the payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Punjab, for the services of a part of the Financial Year, 2014-2015.

BE it enacted by the Legislature of the State of Punjab in the Sixty fifth Year of the Republic of India as follows:-

1. This Act may be called the Punjab Appropriation (Vote-on- Short title
Account) Act, 2014.

2. From and out of the Consolidated Fund of the State of Punjab, Issue of Rs.
there may be paid and applied, sums not exceeding those, specified in column 252,92,96,20,000/-
5 of the Schedule, appended to this Act, amounting in aggregate to a sum of out of the
Rs. 252,92,96,20,000/- (Rs. Twenty five thousand two hundred ninety two Consolidated
crore ninety six lacs and twenty thousand only) towards defraying the several Fund of the State
charges, during the Financial Year, 2014-2015, in respect of the services and of Punjab for the
purposes, specified in column 2 of the said Schedule. financial year,
2014-2015.

3. The sums authorized to be paid and applied from and out of Appropriation.
the Consolidated Fund of the State of Punjab by this Act, shall be appropriated
for the services and purposes, expressed in the said Schedule in relation to the
Financial Year, 2014-2015.

4. Notwithstanding anything contained in any other Act for the Overriding effect
time being in force, the provisions of this Act shall prevail. of the Act
