PUNJAB ACT I of 1898.

An Act to shorten the language of Acts and for other matters.

WHEREAS it is expedient to shorten the language used in ³[Punjab Acts] and to make certain provisions for the construction of, and other matters relating to such Acts; it is hereby enacted as follows:—

PRELIMINARY.

1. (1) This Act may be called the Punjab General Clauses Act, 1898; and

GENERAL DEFINITIONS.

2. In this Act and in '[all Punjab Acts] '[* * *]. unless there is anything repugnant in the subject or context,—

Abet.

(1) "abet", with its grammatical variations and cognate expressions, shall have the same meaning as in XLV of the Indian Penal Code³:

Act.

(2) "act", used with reference to an offence or a civil wrong, shall include a series of acts, and words which refer to acts done extend also to illegal omissions:

Affidavit.

(3) "affidavit" shall include affirmation and declaration in the case of persons by law allowed to affirm or declare instead of swearing:

Barrister.

- (4) "barrister" shall mean a barrister of England or Ireland or member of the Faculty of Advocates in Scotland:

British possession.

(6) "British possession" shall mean any part of Her Majesty's Dominions, exclusive of the United Kingdom, and where parts of those Dominions are under both a central and a local Legislature, all parts under the central Legislature shall, for the purposes of this definition, be deemed to be one British possession:

GENERAL RULES FOR CONSTRUCTION.

- 3. '[Where any Punjab Act is not expressed to coming into come into operation on a particular day, then,— operation of energian of energia
 - (a) in the case of a Punjab Act made before the commencement of the Constitution, it shall come into operation, if it is an Act of the Legislature, on the day on which the assent thereto of the Governor, the Governor-General, or His Majesty, as the case may require, is first published in the Official Gazette and, if it is an Act of the Governor, on the day on which it is first published as an Act in the Official Gazette; and
 - (b) in the case of a Punjab Act made after the commencement of the Constitution, it shall come into operation on the day on which the assent thereto of the Governor or the President, as the case may require, is first published in the Official Gazette;

and in every such Act the date of the first publication thereof shall be printed either above or below the title of the Act and shall form part of every such Act.]

- 4. Where this Act or any Punjab Act ²[* * * *] Effect of repeal repeals any enactment then, unless a different intention appears, the repeal shall not—
 - (a) revive anything not in force or existing at the time at which the repeal takes effect; or

- (d) affect any penalty, forfeiture or punishment incurred in respect of any offence committed against any enactment so repealed: or
- (e) affect any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid;

and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such penalty, forefeiture or punishment may be imposed as if the Repealing Act had not been passed.

Repeal of Act Act.

Powers and Functionaries.

Powers confer-red on the State Government to be exercisable from time to time.

12. Where, by any Punjab Act, '[* * * *] any power is conferred 2[* * *] then that power may be exercised from time to time as occasion requires.

Power to appoint exofficio.

13. Where, by any Punjab Act, 1[* * *] point to include power to appoint any person to fill any office or execute any function is conferred, then, unless it is otherwise expressly provided, any such appointment may be made either by name or by virtue of office.

Power to append or dismiss.

14. Where, by any Punjab Act, '[* * *] a power point to include to make any appointment is conferred, then, unless a different intention appears, the authority having ³[for the time being] power to make the appointment shall also have power to suspend or dismiss any person appointed '[whether by itself or any other authority] by it in exercise of that power.

Substituted functionaries.

15. In any Punjab Act, '[* * *] it shall be sufficient, for the purpose of indicating the application of a law to every person or number of persons for the time being executing the functions of an office, to mention the official title of the officer at present executing the functions, or that of the officer by whom the functions are commonly executed.

Successors.

16. In any Punjab Act, '[* * *] it shall be sufficient, for the purpose of indicating the relation of a law to the successors of any functionaries or of corporations having perpetual succession, to express its relation to the functionaries or corporations.

Official chiefs and subordinates.

17. In any Punjab Act, '[* * *] it shall be sufficient, for the purpose of expressing that a law relative

- (4) the authority having power to make the rules or bye-laws, and, where the rules or byelaws are to be made with the sanction, approval or concurrence of another authority, that authority also, shall consider any objection or suggestion which may be received by the authority having power to make the rules or bye-laws from any person with respect to the draft before the date so specified;
- (5) the publication in the 2[Official Gazette] of a rule or bye-law purporting to have been made in exercise of a power to make rules or bye-laws after previous publication shall be conclusive proof that the rule or byelaw has been duly made.

 - (b) in relation to any Ordinance promulgated by the Governor of Punjab, under article 213 of the Constitution or any Regulation made by the Governor under paragraph 5 of the Fifth Schedule to the Constitution, as they apply in relation to Punjab Acts made by the State Legislature.
