Indian Institute of Public Administration (IIPA), New Delhi is going to conduct a five-day training programme on "**Environmental Sensitization for Good Governance**" from December 18-22, 2017 for the officers to be derived from Indian Administrative Service/Indian Police Service/Indian Forest Service. The participating officers to be nominated for the programme would be in the rank of Addl. Commissioner, DIG, and Conservator from the IAS, IPS and IFS cadres, respectively.
